- 3. Minutes of the previous meeting held on 5<sup>th</sup> May 2017 & Extra Ordinary meeting on 18<sup>th</sup> May 2017 were signed as an accurate record of the meeting.
- 4. Finance Notes

Councillors were asked to approve the schedule of payments. Councillors were asked to approve the finance notes for April 2017 month-end

6. Chairman's Report

Cllr Blamey, reported that he had recently attended a seminar on the Neighbourhood Plan and advised the council that he will be putting together a guide on Neighbourhood Plans and will present it to the council at the next meeting.

9) Donation request – Halstead Primary School

Halstead Primary School have asked for a donation towards energising their playground facilities. The total cost for this is £5000. Halstead Primary School are asking for donation of £500 towards the total cost. Councillors discussed the donation request in detail, Cllr Blamey proposed a donation of £200, with Cllr Grint seconding it.

**RESOLVED:** That the council donate £200 to the school.

10. Jenkins Neck Wood

Councillors were asked to agree to the proposed terms of reference (appendix A)

**RESOLVED:** That the terms of reference are agreed.

11. Donation request – BMRA

The BMRA have requested a donation towards strimming areas of Badgers Mount, the cost of strimming is £300, for the 1<sup>st</sup> 2 strims. Councillors discussed the areas that are to be cut and how many times Shoreham Parish Council cut the areas.

**RESOLVED:** That the £300 is paid from contingency and that we check with Shoreham Parish Council as to how many times they cut the areas. That any further requests for money for the strimming is brought back to a meeting for agreement.

12. Defibrillator

The British Heart Foundation's grant funding is currently still closed. The Clerk has sought quotes to purchase a defibrillator out right. One received from AEDheart safe at a cost of £1994 plus VAT and one from Welmedical at a cost of £1356.25 plus shipping at a cost of £9.95 plus VAT. Councillors discussed other options and agreed to look at further companies. It was also suggested that we speak to the school to see if they can purchase a defibrillator on behalf of the council at a cheaper rate.

**RESOLVED:** That more research is done on costs and brought back to a meeting. That Cllr McCartney speak to the school if they could purchase a defibrillator through their contacts at a reduced rate.

- Q: Mr Woledge thanked Cllr Grint for attending the BMRAs AGM and asked if Cllr Grint had followed up with SDC regarding if any monies changed hands for Jenkins Neck Wood
- A. Cllr Grint advised that he is still waiting to hear back from them but will keep chasing.
- Q. Mr Woledge advised that the BMRA have set up a working group who are looking at Jenkins Neck Wood's history and they how to measure noise pollution. Mr Woledge also asked what the cost of the woodland is?
- A. Cllr Blamey noted that we have asked the question on the cost of the Woodland but we have had no firm figures, but have been advised that woodlands of that size are valued at around £85,000. Cllr Plumb noted that he recently saw an article that advised trees in urban areas significantly improve noise pollution.
- Q. Mr Woledge advised the council that we should not spend all our budget on the Mount and ensure if it is used for the whole of Badgers Mount.
- A. It was agreed to look at the possibility of planting flowers at the signs/gates for Badgers Mount.
- Q. Cllr Plumb noted the e-mail from Cllr N Chard regarding the 402 and that we have had confirmation that they will be putting on a bus route from Orpington to Sevenoaks running 3 ways on way and 4 the other. A discussion on the new bus route and the proposed meeting at Knockholt on 22<sup>nd</sup> June 2017.
- Q. Cllr Grint advised that he has being in touch with the owners of the nursing home, who have been in touch with the bus company to advised of the new nursing home which in turn will see more people wanting to use the service. Cllr Blamey noted that the bus company could afford to run a service at a loss for the community.
